

Welfare Policy in Greece: The Greek Welfare State on the Move... "SNAPSHOTS"

Ferrera (1996) concludes that the southern European welfare state is a distinctive model. While formally it resembles other "corporatist" (and Catholic) counties, there is a different "socio political etiquette". These welfare regimes are not embedded in open universalistic political cultures with solid, impartial Weberian state bureaucracies. They are closed, particularistic cultures with relatively weak state apparatuses. The reasons for this particular development are several: persistent economic and political "backwardness"; sectoral and territorial dualism; amoral familism; a strong Catholic [Orthodox in Greece] church and a weak political left; weak institutions, especially in regard to bureaucratic professionalism and autonomy; the prominence of political parties in the absence or atrophy of other institutions of civil society; and ideological polarization with maximalist and divided political Left. (Kleinman 2002, p. 50).

What are the characteristics of the Mediterranean model?

- 1. In terms of income maintenance, these welfare states are not only highly fragmented, especially Italy and Greece, but are also characterized by strong internal polarization (Ferrera, 1996).
- 2. In Mediterranean welfare states there has been some departure from corporatism through the creation of national health systems on universalistic principles.

What are the characteristics of the Mediterranean model?

- 3. There is a low degree of state activity in the welfare sector.
- 4. These welfare states are clientelistic and particularistic. This includes straightforward political corruption, but more typically political clientelism, trading favours for votes.

- Traditionally the Reception System for Refugees and Asylum Seekers has fallen under the responsibility of the *Ministry of Health and Social Solidarity*.
- Since July 2012 according to Law 4052/2012, the General Secretariat for Welfare has been transferred to the *Ministry of Labor, Social Insurance and Welfare*, thus the responsibility for the protection of refugees and asylum seekers along with the management of the ERF is currently the responsibility of the Ministry of Labor, Social Insurance and Welfare.
- However, according to Law 3907/2011 the First Reception Service is under the *Ministry of Public Order and Citizens Protection*.
