## 8 Signature

The information will be registered in the computer system for immigrant and refugee cases (DUF). This information may also be used in relation to later applications and applications from family members.

Your information may be passed on to other relevant authorities in order to check and obtain more details of the information you have given. Where necessary, information about you will also be collected from other Norwegian and foreign authorities, including the police. We will not obtain information from foreign authorities if this may entail a risk to your safety. If you are granted a permit, information on this will be entered in the National Population Register.

If you violate the Norwegian Immigration Act or the General Civil Penal Code, you may, in addition to being punished, be rejected upon entry or expelled, and registered in the Schengen Information System. If you are granted a permit on the basis of incorrect or incomplete information, the permit can be revoked.

UDI will use your phone number and e-mail address to contact you in the further application process in this and future applications. It is therefore important that you check that you agree to receive information about your case on sms / e-mail.
